#### 3.1 Renewing/New Membership

# 4.3 DCD and Dysgraphia Working Party

## Dysgraphia group

Focusing on the OT role and whether OTs can diagnose for dysgraphia. The party is putting guidelines in place aimed at OTs in schools. The aim is to become unified as a profession to decide on diagnosing dysgraphia. As well as once a child has a diagnosis, what therapy/aids

do they actually have prescribed. The party is also looking at the age range i.e. what does an 8-year-old vs 14-year-old require.

## DCD group

Decided that an OT cannot diagnose DCD as there is a need to rule out other neurological conditions first. Currently trying to work out a way to pull together the work that has already been done.
